

2017 Randolph Town Pool Rental

The Randolph Town Pool is available for group rentals during times when there are no scheduled special events or lessons. All rentals must be approved by the Recreation Director or Pool Director **before** the date of the rental. Exclusive rentals are \$100 per hour, and shared pool time will be available for \$75 per hour. There is an **additional fee** for groups over 50 people of \$10 per hour per lifeguard. Number of lifeguards depends on the number of people.

- No instruction will be provided during the pool rentals.
- We expect all groups to provide an adequate number of chaperones to supervise children in and around the pool. We will not assign additional staff to assist with your party.
- Concessions are available and range in price from .25¢ to \$1.75.
- The Pool staff will go over the rules with the rental group upon arrival.
- Each rental is subject to weather. Call ahead if you have questions about weather cancellations.
- Full payment for rental must be received prior to the time of the rental.

Applications must be filled out completely and returned to the appropriate facility with a \$100 deposit. Upon arrival to the facility, the balance will be due. Applications are subject to the approval of the facility manager. All persons entering pool area must be counted in totals; including non-swimming adults.

Outdoor pool rentals are subject to cancellation due to severe weather

- All guests must leave the pool deck if there is thunder or lightning. The pool deck will remain clear for 30 minutes after the last lightning strike or thunder.
- If there is persistent inclement weather on the day of your rental, the facility manager may request a rescheduled date to be chosen.
- Pool rentals cancelled due to inclement weather can be rescheduled. If a rescheduled date is not available, the deposit can be refunded.

GENERAL RULES

- Children 8 years and under must be accompanied by an adult 18 years of age or older at all times.
- Swimsuits are required to enter pools. (Un-lined and cut-off shorts or leotards are not allowed).
- Food and beverages are allowed only in the designated concession areas.
- NO ALCOHOLIC BEVERAGES ARE ALLOWED AT THE POOL.
- No smoking permitted at any park facility.
- Children who are not toilet trained must wear tight fitting plastic pants or swim diapers.
- All swimmers must take a shower before entering pool.
- All other state and local health codes apply.
- Persons applying for a pool rental must be 21 years of age.
